#### 27/21 STANDING ITEMS

a. No notice had been received of any Member becoming ineligible to hold office, the meeting was quorate and there were no agenda related interests declared.

b. The Chair explained that the special meeting had been called to consider an adjustment to the sub-contracting financial limit.

### 28/21 SUB-CONTRACTING

It was planned to continue the sub-contracting arrangements with Learning Curve. Results for their 2020/21 short distance learning courses had been almost "Outstanding" and associated risks were low. Adult provision, severely and adversely affected by lockdowns, had not yet fully recovered although progress was being made. The numbers were also being further hit by high employment and the forecast was for £950k shortfall against allocation. The proposed contract value for the continuation of the subcontract with Learning Curve was for a value up to £850k (£750k in 2020-21) and Members were asked to approve the increase, and after full consideration, that was approved wie.
